SHOW RULES

- 1. ELIGIBILITY:** Open to all Colorado artists.
- 2. THEME:** Artwork depicting anything typical of traditional or contemporary Asian, Hawaiian or Western cultures and life.
- 3. WHEN:** August 30-October 1, 2010
- 4. WHERE:** LAC Community Art Center & Gallery
85 S. Union Blvd, Lkwd. 80228-2207
- 5. MEDIA:** Any two or three dimensional fine art media, incl. photography & digital, fiber, pottery, sculpture. (No crafts)
- 6. FEE:** \$7.00 per work (\$6.00 MAG members).
Make checks payable to: Mountainside Art Guild. (Fees are non-refundable)
- 7. ENTRIES:** Each artist may submit up to 4 original works (no prints from originals).
For 2-D work: works must be framed or have wrapped, painted edges with staples exposed only on the back; must be dry and ready for hanging with screw eyes and wire. No sawtooth or clip hangers. Entries with improper wiring will be disqualified.
- 8. IDENTIFICATION:** All works must be identified on the back with artist's name, phone number, title. HAVE WORKS READY PRIOR TO DELIVERY!!
- 9. JURYING:** Works will be juried for acceptance into the show. JUROR BECKYENABNIT SILVER the owner of the Aar River Gallery in Westminster. She is an instructor who specializes in watercolor. View her website at www.beckyenabnitfineart.com
AWARDS: (winners will be called)
Best of Show: \$100
Second Place: \$ 75
Third Place: \$ 50
Merit Awards: \$ 25 ea.

SALES: Works need not be for sale.
A 10% commission will be charged on all sales.
Artists will be notified in the event of a sale.

INSURANCE: No insurance is provided.

Pick up unsold work.
